Below is the Staff's Report for the December 11, 2014 Board Meeting.

## **Engineering, Operations, Construction & Maintenance**

- Staff is working with All Aboard Florida (AAF) on a potential rail alignment along a portion of SR 528.
- We have completed the 60% plans for the Innovation Way Interchange Project. It is currently on hold.
- Wekiva Parkway:
  - Completed 100% plans for the two sections north of US 441.
  - o Project 429-202 has been submitted to FHWA as required per TIFIA loan.
  - O Right of way acquisition for the first two sections is proceeding on schedule.
    - The Right of Way Certificate for Project 429-202 has been issued by FDOT.
- 2040 Master Plan Update:
  - Individual meetings with Board Members will be scheduled.
  - Phase I involving data gathering and meeting with other public agencies is complete.
- OOCEA's Traffic & Revenue Consultant has begun the Fiscal Year 2014 Annual Report.

- The Authority has advertised for requests for proposals to replace toll collection equipment in the lanes.
- The Authority has received Letters of Interest and shortlisted for the following projects:
  - o Improvements to SR 408 from SR 417 to Alafaya Trail
  - o Project Development and Environmental (PD&E) Study of SR 408 extension from the existing east terminus east to SR 520
- The Authority will be advertising for Letters of Interest for the following project:
  - Improvements to SR 408 from Hiawassee Road to Good Homes Road

## Finance and Administration

- The Director of Human Resources is currently recruiting for the position of Office Coordinator for the Finance and Accounting Department.
- Proposals for the Toll System Replacement project are due December 19, 2014.
- CFX staff is in the final stages of acquiring a USDOT Transportation Infrastructure
  Finance and Innovation Act (TIFIA) loan for Section 2 of the Wekiva Parkway.

  Negotiation of the loan terms is expected to begin soon. The loan will advance the
  project 1½ years and save approximately \$120 million in financing costs over a 35 year
  period.
- CFX staff is working with Florida's Turnpike, Miami Dade Expressway Authority and Tampa Hillsborough Expressway Authority to negotiate a Centralized Customer Service System (CCSS) agreement that will define the governance and management of CCSS development and implementation.
