SUBJECT: Settlement Release with National Interstate Insurance Company for Repairs on S.R. 408 Crash on March 23, 2014

CFX staff has been diligently pursuing a claim against Shelly's Septic Tank, Inc. and its insurer National Interstate Insurance Company for repair damages incurred as a result of a collision on westbound S.R. 408 which destroyed a full span sign truss and attendant signing and lighting.

The insurer has now agreed to pay 100% of CFX's claim which totaled \$172,007.82. A check for \$164,986.73 (copy attached) has been received and deposited and an additional check for \$7,021.09 is forthcoming (see attached email).

Staff recommends authorization for the Chairman to sign the attached release as requested by National Interstate.
