CFX LEGAL DEPARTMENT OVERVIEW



- Office of in-house General Counsel became operational on June 27, 2007, following a legal services efficiency study conducted by management and Board approval
- Previously private law firms acted as General Counsel to the agency
- Originally projected annual savings up to \$300,000 was far exceeded by empirical data showing \$830,000 in savings after first two years



- Position originally reported to Executive Director, but was changed to report directly to the Board in 2009 per resolution 2009-087
- Serves as CFX's Ethics Officer per Fla.Stat.348.753 (7)
