CALL TO ORDER

The workshop was called to order at 10:35 a.m. by Chairman Welton Cadwell.

PUBLIC COMMENT

There was no public comment.

CFX VISIONING

Michelle Maikisch explained that the purpose of today's workshop is to talk about CFX's vision and where we want to be in the future. The feedback received today will be used to develop the CFX vision statement. At a future meeting, the vision statement will be presented and voted on.

Ms. Maikisch talked about the public input process and outcomes:

Since April, the 2040 Master Plan and Visioning Team has facilitated an extensive public outreach campaign that included 78 presentations, meetings and events to gather input via an online survey from community leaders, key stakeholders and residents in Lake, Orange, Osceola and Seminole Counties.

The 2040 Master Plan and Visioning Survey was shared on multiple websites, e-newsletters and social media pages throughout Central Florida. Over 330 responses were received from May 6 to July 30.

Recently CFX employees were engaged in a visioning exercise that asked them how they saw CFX today and what they aspired it to be in the future. From these sessions, 5 core values were identified and voted upon by all 59 CFX employees:

- Excellence
- Innovation
- Service
- Teamwork
- Commitment

Facilitator Gert Garman walked the board members through the visioning process.

She began by sharing the words and phrases commonly heard from surveys, speaking engagements, interviews, individual board member interviews, employees, and constituent groups that describe CFX aspirations and vision.

With the Board members' input and discussion, these words and phrases were captured into a list of themes that will be used to develop the vision statement of the agency.

In the upcoming months the Board will discuss CFX's mission. These conversations will focus on the resources and tactics needed to achieve the CFX vision. The discussions will include multimodal opportunities, customer service requirements, the investment of toll dollars, etc.
