

# Board Visioning Workshop Recap CFX Vision + Mission Statement

On August 13, the CFX governing Board participated in a Visioning Workshop facilitated by Gert Garman of the Valencia College Collaborative Design Center. Board members discussed the informed clues garnered from surveys, speaking engagements, interviews and meetings with the Board, customers, employees and constituents. Out of the workshop discussion came themes and phrases that best describe CFX's aspirations for the next 50 years.

The CFX vision statement incorporates the keywords and phrases into one succinct statement. From the extensive feedback at the workshop, the 2040 Master Plan + Visioning team also moved forward with creating a mission statement to support the vision statement.

At the September Board meeting, the Board will vote to adopt the new vision and mission statement. These statements, along with the employee values, will become the DNA of the agency.

The Board will continue to participate in workshops/retreat to further discuss resources and tactics needed to achieve the CFX vision and mission. It will be during these workshops/retreat where the Board may discuss multimodal opportunities, customer service requirements, the investment of toll dollars, etc.
