In accordance with the approved Procurement Policy and Procedures for an invitation to bid, the Procurement Department opened sealed bids on June 22, 2015, for the referenced project. Bid results were as follows:

2.	Ranger Construction Industries, Inc.	\$2,137,490.76
3.	Hubbard Construction Company	\$2,385,057.67

The Engineer's Estimate for this project is \$1,733,341.80.

A fifth bid was received and opened but was subsequently rejected as non-responsive to the bidding requirements because the bidder did not use the revised bid form issued by addendum.

The Procurement Department has evaluated all bids and has determined the bid from Southland Construction, Inc., (Southland), to be responsible and responsive to the bidding requirements. Award of the contract to Southland in the amount of \$2,042,198.88 is recommended contingent upon final execution of the contract by both parties.

#### **CONTRACT**

This Contract No. 001101 (the "Contract"), made this 9<sup>th</sup> day of July, 2015, between the CENTRAL FLORIDA EXPRESSWAY AUTHORITY, hereinafter called the AUTHORITY and SOUTHLAND CONSTRUCTION, INC., of 172 West Fourth Street, Apopka, Florida 32703, hereinafter the CONTRACTOR:

WITNESSETH: The CONTRACTOR shall, for the consideration herein mentioned and at its cost and expense, do all the work and furnish all the materials, equipment, supplies and labor necessary to perform this Contract in the manner and to the full extent as set forth in the Contract Documents (and under security as set forth in the attached Public Construction Bond) all of which are hereby adopted and made part of this Contract as completely as if incorporated herein. The Contract shall be performed to the satisfaction of the duly authorized representatives of the AUTHORITY, who shall have at all times full opportunity to inspect the materials furnished and the work done under this Contract.

This Contract is accepted and entered into in Florida and any question regarding its validity, construction, enforcement, or performance shall be governed by Florida law. The parties consent to the exclusive jurisdiction of the courts located in Orange County, Florida.

The work to be done under this Contract includes construction of all items associated with Project No. 429-654C, S.R. 429/C.R. 535 South Off Ramp Improvements, as detailed in the Contract Documents and any addenda or modifications thereto. Contract time for this project shall be 150 calendar days. The Contract Amount is \$2,042,198.88. This Contract was awarded by the AUTHORITY's Board of Directors at its meeting on July 9, 2015.


