Continued the financial analysis and valuation of SR 417 in Seminole and Osceola Counties, SR 429 in Osceola County, and SR 528 from I-4 east to McCoy Rd.

CFX is issuing Bond Anticipation Notes (BANs) via a competitive process to help finance the construction of the Wekiva Parkway. We are asking for board approval this month with a closing date of July 10, 2015. The proceeds from the TIFIA Loan will pay off the BANs in 2018.

The CFX team continues to work with All Aboard Florida on final rail construction plans along SR 528.

CFX is proceeding to 90% plans for the Innovation Way Interchange Project. Our team is coordinating with Suburban Land Reserve, Inc. to work out a schedule for completion.

Bids have been received for Project 429-203, Wekiva Parkway, Kelly Park Road interchange. Construction will start in 2015.

We have received 100% plans for Project 429-204, Wekiva Parkway, from the Orange/Lake County line to SR 46.

The CFX team met with Winter Garden engineers to discuss traffic issues at S.R. 429 and C.R. 535.

Wrong way signing and equipment is being installed at SR 408/Hiawassee and Kirkman Road Interchanges.
