Project 528-313, Contract No. 001019

In accordance with the approved Procurement Policy and Procedures for professional services consultants, the Procurement Department advertised for Letters of Interest for the referenced project on November 8, 2015. Responses were received from three firms by the November 24, 2015, deadline. Those firms were: Elipsis Engineering & Consulting LLC.; JBS Engineering Technical Services, Inc.; Target Engineering Group, Inc. The Evaluation Committee voted unanimously to shortlist all three firms.

Technical Proposals were submitted by all three firms for review and scoring by the deadline. As part of the scoring process, the Technical Review Committee heard oral presentations from the firms on February 1, 2016. After the orals presentations were completed, the Technical Review Committee convened and prepared its final ranking. The results of that process were as follows:

If negotiations with Elipsis Engineering & Consulting LLC. are not successful, Board authorization to enter into negotiations with the second ranked firm, JBS Engineering Technical Services, Inc., is requested.
