CFX staff is reviewing current Florida Transportation Commission toll agency performance measures and developing recommended changes to the measures for the Commission's consideration at their upcoming June workshop.

Attended the Orlando EDC Tech Industry Insider Update on April 19th.

Met with Noranne Downs, District 5 Secretary on May 3rd to discuss the possibility of integrating the design of SR 408 extension east to SR 520 with the expansion of SR 50 to co-locate both within existing FDOT public right of way. The Department chose not to pursue this solution because it would cause a two year delay to the widening of SR 50 and it would require CFX utilization of right of way currently owned by FDOT. The SR 408 Extension Preliminary Design & Engineering study will need to identify other alignment alternatives as a result.

The Osceola County Commission unanimously authorized County Manager Don Fisher to work with CFX to negotiate an agreement for CFX to analyze the feasibility of building the segments of the OCX Master Plan as CFX system projects. A draft agreement is being negotiated and is anticipated to be presented to the Board for consideration on July 14th.

Florida Division of Bond Finance staff has indicated that FDOT has directed them to cease work on the valuation methodology to facilitate the buy/swap of SR 417 and SR 429 in Seminole and Osceola Counties.

Subject: SR 528 and Truck Platooning Pilot Project

Dear Ms. Gutierrez-Scaccetti:

I would like to suggest the Florida Department of Transportation consider SR 528 as the location for the pilot project to test the operation of driver-assistive truck platooning technology called for in Section 54 of HB 7061 adopted by the legislature in the 2026 session.

The Canaveral Port Authority is experiencing significant freight cargo growth particularly of automobile and aviation fuel and containerized freight. All freight movement to and from Port Canaveral must use SR 528. Trucks carrying general cargo, containers and automotive fuel generally travel SR 528 to I-95, Florida's Turnpike or I-4. Aviation fuel tank trucks travel from the Port to Orlando International Airport. Canaveral Port Authority staff should be able to identify trucking companies that regularly carry aviation fuel or containers on SR 528. Such firms would be those most likely to benefit from participation in the pilot project.

SR 528 is under the jurisdiction of three agencies: The Turnpike Enterprise, "regular" FDOT and the Central Florida Expressway Authority. A successful pilot program would require the cooperation of all three agencies. Reaching an agreement would be the first task of the pilot program, and I am certain it can be achieved. All three groups are aware of the long-term economic importance of SR 528, the importance of freight movement to our economy and the necessity of testing and adopting new transportation technologies.

I wish to express my gratitude to Carol Scott, Shannon Estep and Michael Shannon of the Turnpike staff and Suzanne Murtha from Atkins for meeting with Brevard County and TPO stall on May 2 to discuss the incorporation of connected and autonomous vehicle technologies in the design of the widening of the Turnpike Enterprises's eastern section of SR 528. We covered driver-assistive truck platooning, its potential application on SR 528 and the legislative pilot program directive. At that time, knowing the freight growth anticipated on SR 528 and the relative isolation of that traffic from other interstate trucking, I volunteered to write this letter calling attention to SR 528 as an ideal location for the pilot study.




