Hi Phil, Alice and Lee: I looked at the attached map and project description that Lee Hutchinson from ACI sent regarding the pond parcels. Based on a quick check of the Lake and Seminole county property appraiser websites, here are the ownerships:

Seminole Co:
Pond 65—private

Lake Co:
Ponds 27 & 39—St. Johns River Water Management District (Neighborhood Lakes)

Ponds 40 & 41—Trustees of the Internal Improvement Trust Fund (no managing agency indicated, anyone know who manages these parcels?)

Pond 42—Orlando-Orange Expressway Authority

Ponds 43, 54, 55, 60—Rock Springs Run State Park

Pond 46—Seminole State Forest/Division of Forestry

So, we can amend the above permit to include the Pond 43, 54, 55, and 60 locations, if this is acceptable to the park folks. ACI will have to apply for permits for the other properties and determine who the land managers are.

Someone seemed to think that our e-mail amendments were not acceptable, however, Rule 1A-32, Florida Administrative Code does not prohibit us from amending research permits via e-mail.

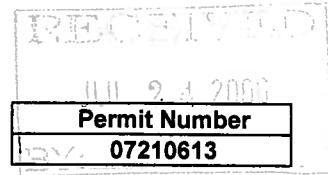
