The [Central Florida Expressway Authority](#) (CFX) is holding a Virtual Pre-Construction Community Meeting for the State Road 417 (Central Florida GreeneWay) Corridor Widening projects: Segment 3 from Landstar Boulevard to Boggy Creek Road.

The virtual meeting is scheduled for **Wednesday, July 22, 2020, 6:30 p.m. to 7:30 p.m.** To participate, please pre-register by 5 p.m. Wednesday, July 22, by visiting <https://bit.ly/SR417VPMJuly2020>. This link is case sensitive. If you are unable to attend at that time, a video of the meeting will be available for viewing at [CFXsr417corridorwideningprojects.com](https://www.cfxway.com/CFXsr417corridorwideningprojects.com) on Friday, July 24. Public comments will be accepted until Friday, July 31, 2020 for public record.

This 3.7-mile project will include widening SR 417 by adding one lane in each direction for a total of six travel lanes. Wider median shoulders will also be added that can temporarily accommodate additional traffic during emergency response events, such as traffic accidents or hurricane evacuations.

CFX conducted a noise analysis and identified eleven locations where a sound wall would be a viable measure to reduce traffic noise. This virtual meeting will provide information on the plans for those sound walls as well as the road widening. Property owners identified as impacted and benefitting from sound walls will be surveyed on whether they want the noise barriers.

This virtual public meeting is the second in a series of public meetings to be held in conjunction with the SR 417 Corridor Widening Projects. The first virtual public meeting, held on June 18, 2020, focused on the first two segments of the corridor widening, from International Drive to Landstar Boulevard.
