

DESIGN DESCRIPTION


The Central Florida Expressway Authority is designing a new four-lane limited access expressway from US 27 to SR 429 which has been designated as State Road 516. The expressway is divided into three segments for design and construction purposes. The new expressway is expected to improve connectivity between Lake and Orange counties, as well as meet future traffic needs.

Segment 3, a 0.9-mile stretch between the Lake/Orange County line and SR 429, features a new interchange with the proposed Valencia Parkway connecting to Schofield Road and a fully directional systems interchange with SR 429, including toll gantries on all interchange ramps and auxiliary lanes.

WHAT TO EXPECT

During design, surveying along the project corridor is done to assist in roadway design, drainage systems, structures and lighting locations, as well as Intelligent Transportation Systems technology such as overhead dynamic message signs and traffic monitoring stations. Geotechnical investigations will also be performed.

DESIGN MAP (LARGER MAP ON BACK)





- Provide evacuation and emergency services access for emergency events such as hurricanes.




The Central Florida Expressway Authority (CFX) is an independent agency of the State of Florida that operates and maintains a regional network of expressways for 3.3 million residents of Brevard, Lake, Orange, Osceola, and Seminole counties and more than 75 million annual visitors to Central Florida. CFX's 125-centerline mile, user-funded system which includes 73 interchanges, 14 mainline toll plazas, 5 mainline gantries, 76 ramp toll plazas and 343 bridges. On average, more than 1.3 million toll transactions are recorded daily, over 95 percent of them electronically.
