

SR 429 CORRIDOR CAPACITY IMPROVEMENTS PROJECT

PROJECT DESCRIPTION

In January 2022, the Central Florida Expressway Authority (CFX) began the 13-mile capacity improvements of State Road 429 (Daniel Webster Western Beltway) from Tilden Road to SR 414 (John Land Apopka Expressway). The capacity improvements, anticipated to be complete by late 2024, are broken into three segments to minimize impact to motorists.

CFX is adding a travel lane to SR 429 in each direction between Tilden Road and SR 414 as well as sound walls along several locations of the expressway. CFX is also implementing a new design element of wider median shoulders that can temporarily accommodate additional traffic during emergency response events, such as traffic accidents or hurricane evacuations.

WHAT TO EXPECT

Anticipated Start Dates

- Segment 1 May 2022: Tilden Road to south of Florida's Turnpike
- Segment 2 January 2022: South of Florida's Turnpike to West Road
- Segment 3 February 2022: West Road to State Road 414

WORK ZONE SAFETY


For the safety of motorists and work crews, speed limits will be strictly enforced during construction. Speeding fines are doubled in work zones when workers are present. Motorists are reminded to change lanes for safety when they see Road Rangers assisting other motorists or flashing lights — it's Florida law.

Estimated Project Cost: \$399 Million


The Central Florida Expressway Authority (CFX) is an independent agency of the State of Florida that operates and maintains a regional network of expressways for 3.3 million residents of Brevard, Lake, Orange, Osceola, and Seminole counties and more than 75 million annual visitors to Central Florida. CFX's 125-centerline mile, user-funded system which includes 73 interchanges, 14 mainline toll plazas, 5 mainline gantries, 76 ramp toll plazas and 343 bridges. On average, more than 1.3 million toll transactions are recorded daily, over 95 percent of them electronically.
