1. FLORIDA WILDLIFE CORRIDOR FOUNDATION UPDATE

He discussed the expedition films that the foundation has created to raise awareness for Florida wildlife and natural habitats. He described the mission of the foundation and discussed native Florida animals and the differences that wildlife crossings make in their lives. He spoke to the partnership with FDOT to create a wildlife crossing at I4. He described what and where the wildlife corridor is, and the acreage associated with it. He discussed the functions of the corridor, and the priorities, bottlenecks, and hotspots identified. He presented a map of the CFX region and the Florida Wildlife Corridor.
