PROJECT DESCRIPTION

The Central Florida Expressway Authority (CFX) is designing a half interchange on State Road 429 (Daniel Webster Western Beltway) at Binion Road. The project area runs along the vicinity of South Binion Road and Boy Scout Road at SR 429. Currently, in order for drivers to access SR 429 in Southwest Apopka, they must enter and exit SR 429 by driving approximately three miles north to just north of US 441 at the SR 429 Connector Road interchange or travel three miles south to the interchange at Ocoee Apopka Road. This half interchange will improve mobility in the project area by adding a northbound on-ramp from Binion Road and a southbound off-ramp to Binion Road.

As part of this project, noise walls are planned from the new northbound on-ramp to Lust Road for the Binion Reserve and Ivy Trail subdivisions.


Improves connectivity opportunities for Apopka residents.








The Central Florida Expressway Authority (CFX) is an independent agency of the State of Florida that operates and maintains a regional network of expressways for 3 million residents of Brevard, Lake, Orange, Osceola, and Seminole counties and more than 75 million annual visitors to Central Florida. CFX's 125-centerline mile, user-funded system includes 73 interchanges, 14 mainline toll plazas, 5 mainline gantries, 76 ramp toll plazas and 369 bridges. On average, more than 1.6 million toll transactions are recorded daily, nearly 98 percent of them electronically. CFX operates E-PASS, the first electronic toll collection system in Florida, with more than one million E-PASS accounts. For more information, visit CFXwav.com

During construction, temporary lane and ramp closures will be necessary to accommodate work. To minimize the impact of construction to motorists traveling on SR 417, lane closures will not be permitted during peak travel times. Night and weekend work will occur on this project.


